Members of the Board of School Trustees met in executive session at 5:45 p.m. on this date in the Brown Elementary School Conference Room pursuant to Indiana's Open Meetings Law for the purpose of: discussion with respect to any individual over whom the governing body has jurisdiction: to discuss, before a determination, the individual's status as an employee, a student, or an independent contractor. No topics were discussed other than those listed on the public meeting notice. All members were present.

President Juergens called the Regular Board meeting to order at 7:02 p.m. All members were present.

SUPERINTENDENT COMMENTS:

Mrs. Lister shared the ISTEP test results and Accountability report.

Mr. Stark gave a facilities update.

BOARD COMMENTS:

Members of the Board wished everyone a Merry Christmas. Mrs. Franke gave "kudos" to all the Christmas programs. Mr. Browning thanked the Athletic Department for the quick response in helping a student's family who lost everything in a house fire. Mr. Juergens thanked the Board for a successful 2016. He looks forward to what will be accomplished in 2017.

ACTION ITEMS

Mrs. DuBois made a recommendation to add Math 10 as an approved high school course. Mr. Joray moved and Mr. Silver seconded. Motion carried; 7-0.

Mr. Hack made a recommendation to approve the school sign specifications and requested permission to seek bids. Mr. Klosterman motioned and Mrs. Franke seconded. Motion carried; 7-0.

Mr. Fosbrink made a recommendation to award the transportation lighting project to Bode Electric for \$14,679. This includes three new poles with lights matching what is currently located at the transportation center. The LED option would cost \$22,419 for the three new poles and replacing the existing poles with LED lighting. Mr. Klosterman made a motion to award to Bode Electric and Mr. Silver seconded. Mr. Kelley asked about a warranty and how much we could save if we switched to the LEDs. Mr. Klosterman withdrew his motion. Mr. Fosbrink will return next meeting with additional savings information.

Mr. Fosbrink made a recommendation to purchase one conventional 78 passenger bus from Midwest Transit for \$103,379.97 and two 90 passenger buses from Kerlin Bus Sales for \$240,603.94 for a total of \$343,983.91 to be paid out of the bus replacement fund. Mr. Joray motioned to approve the purchase and Mr. Browning seconded. Motion carried; 7-0.

Mr. Harpe made a recommendation to modify the 2017-2018 school calendar to reflect this year's calendar. Mrs. Franke moved and Mr. Joray seconded. Motion carried; 7-0.

Mr. Manns made a recommendation to approve sound system specifications and seek quotes for Seymour High School track and soccer materials and/or equipment. Mr. Nauman added they must decide if they want to pursue this project now so the funds can be encumbered. Mrs. Franke motioned to approve specs and allow Mr. Manns to seek quotes. Mr. Joray seconded. Motion carried; 7-0.

Mr. Manns made a recommendation to hang windscreens around the soccer complex to keep spectators from standing behind the goals and to enhance the look. There is money left over from the project that must be used for the specific project. Mr. Kelley motioned to waive the first read and Mrs. Franke seconded. Motion carried; 6-1 with Mr. Klosterman voting against. Mr. Browning motioned to approve the purchase of windscreens from Mid American Sports Advantage and Mrs. Franke seconded. Motion carried; 7-0.

Mrs. Ahlbrand share the December 1 Special Education count. Since 2012, the special education department has increased by 295 students. There was also a total funding increase of \$921,288.

Mrs. Ahlbrand requested permission to apply for IDEA FY 2017 Part B Special Ed Grant. She thanked Mr. Nauman for his assistance in preparing the information for these annual grants. She also thanked Mrs. Duggins who keeps track of student records and scheduling testing. Mr. Browning moved and Mr. Silver seconded. Motion carried; 7-0.

Mrs. Altemeyer requested permission to apply for the 2016-2017 High Ability Grant and 2016 Title IIA Grant. Mr. Silver moved and Mr. Klosterman seconded. Motion carried: 7-0.

Mr. Hooker made a recommendation to award the quotes under \$25,000 for the 2017 calendar year for:

Mrs. Franke motioned to approve and Mr. Kelley seconded. Motion carried; 7-0.

Mr. Hooker made a recommendation to seek bids for contracts greater than \$25,000 for the school year beginning in 2017-2018 for:

- Inspection & Service Reports for bleachers, backstops, divider curtains, wrestling mats, etc.
- Purchase of Natural Gas Futures

- Security Systems Service
- HVAC Software & Mechanical Systems
- Fire Protection Services

- Refrigeration Maintenance
- Boiler Service & Maintenance

 Grounds Pruning, Mulching, & Insect Control Services

Mr. Silver moved and Mr. Browning seconded. Motion carried; 7-0.

Mr. Hooker made a recommendation to approve the 2017 Board Meeting dates. He also informed the Board of a change of date for the January meeting due to Indiana Statute. The Reorganization, Board of Finance, and Regular January Board meetings need to be moved to January 10, 2017. Mr. Klosterman motioned to approve and Mr. Kelley seconded. Motion carried; 7-0.

Mr. Hooker made a recommendation to approve the following policies & guidelines as presented:

8453 - Operations - Control of Non-Casual-Contact Communicable Diseases

Mr. Joray questioned the policy pertaining to the lice and said he still had open questions he felt were not answered from last time. He then asked why we check anyway. If the parents are aware, they can take care of it. Mr. Klosterman motioned to approve the policies and guidelines as presented and Mrs. Franke seconded. Motion carried; 5-2 with Mr. Joray and Mr. Silver voting against.

Mr. Hooker shared a draft of the 2017 Goals. He asked that any suggestions be directed toward him prior to the January meeting.

Mr. Hooker shared additional policies and administrative guidelines for review. He made a few tweaks to the current policies and included a glossary of terms.
